I, the undersigned, hereby apply for levelized billing to the residence at the address listed herein above with all service being supplied by Ocmulgee Electric Membership Corporation in accordance with the Service Rules and Regulations established by said Corporation (a copy of which appears on back) and any future changes and modifications hereinafter so adopted by said Corporation.

I understand and agree that my monthly bill will be based on my average consumption for the most current 12 months usage.

In case I am a new member, the bill be based on the average of the then available billing history in my account (total usage to date dived by the number of months history available until such time as I have 12 months history.) **I will satisfy all deposit requirements prior to being laced on levelized billing.**

I further understand and agree I may be removed from the levelized billing if I fail to pay all bills promptly when rendered. I will at that time pay my balance in full and return to regular-monthly billing. I understand at any time I choose to return to regular monthly billing, move to another residence, or when I discontinue service, the balance on my account will be due and payable or any credit refunded.

If my account is referred for collection by Ocmulgee Electric to any outside agency and/or attorney who is not a salaried employee of Ocmulgee Electric, I will to the extent permitted by law, pay all fee and /or court costs.

It is further understood when a rate increase or decrease occurs, my payment may be adjusted accordingly.

It is understood and agreed that this agreement will continue from month to month and year to year so long as I am a consumer and so long as I promptly make all payments due under this agreement or until such time as either party requests discontinuance of this levelized billing agreement.

SERVICE RULE 508
LEVELIZED BILLING

A member may be offered the option with the Cooperative's approval to use a payment method, which has the effect of a levelized bill. An additional security deposit may be required based on the member's past payment history. Details of this billing method are available upon request.

A system of levelized billing has been approved by the Board of Directors for all residential members of Ocmulgee Electric Membership Corporation. Both new and existing members with acceptable credit history may apply.

The levelized bill will be based on the average consumption for the most recent 12 months usage. Members with less than 12 months billing history will be billed on the average of whatever history is available and adjusted monthly until 12 months history is available. The bill amount will not be the same each month but will increase or decrease slightly as the consumption pattern changes. The real benefit to the members will be to prevent extreme fluctuations in payments because of seasonal increases and decreases in power used. The member will continue to pay the same rate as all other members.

In fairness to all members of the cooperative and to prevent increased liabilities from this group of members who elect to use levelized billing, a fair but strictly controlled procedure will be followed: (1) **New members** will be required to satisfy all deposit requirements prior to using the plan. (2) **Existing members** who apply must have an acceptable credit history with no actual disconnects for non-payment, no collection notices from meter readers, or returned checks. (A delinquent notice will not be considered if bill was paid in time to be processed before a collection notice was forwarded to the meter reader.)

REMOVAL FROM LEVELIZED PLAN

Any member using the plan who has two or more collections by a meter reader in 13 months will be advised that upon having a third collection he will be returned to the regular billing system. A member removed for the above reasons may reapply as soon as his credit history again meets the conditions as required by any other member.

The levelized billing provision will become effective March 1, 1986.
